POLICY DOCUMENT FOR SCHOLARSHIPS AND FREESHIPS WITH EFFECT FROM ACADEMIC YEAR 2020-2021

Context

Scholarship Policy of Our College encourages a good number of students every year and kindles the spirit of consistence performance. The policy considers award of one scholarship and/or adjustment toward tuition fee and/or tuition fee waiver to a meritorious student in each discipline per academic year.

Objectives of the Policy

- To provide financial assistance to the SC/ST students, meritorious students, Girl students, sports quota, ward of farmers, orphans, muslim students, students supported by NGO's, wards of frontline workers, wards of COVID victims and non- creamy layer students to enable them to pursue professional and technical courses.

CATEGORY 1: SCHOLARSHIPS IN TUITION FEES

(A) MERIT BASED SCHOLARSHIP POLICY

For UG Programs: Merit Scholarship can be availed on the basis of XII standard percentage at the time of admission and the same is applicable on the Program Tuition fees.

For PG Programs: Merit Scholarship can be availed on the basis of Graduation percentage at the time of admission and the same is applicable on the Program Tuition fees.

To continue the scholarship, the student should maintain a CGPA 6.5 and above every year, without any backlogs and Indiscipline case.

* Note: only 10 % of students from each Department can avail this benefit.

(B) SCHOLARSHIP ON THE BASIS OF PERFORMANCE IN SPORTS

The scholarship amount will be awarded as per Sports Quota Scholarship policy which is applicable on Tuition Fee only. The Sports Scholarship in subsequent years of the program will be reviewed on annual basis.

(C) SCHOLARSHIP FOR GIRL STUDENTS

Scholarship of 10% of Tuition fees is applicable for Girl students in first year for UG programs subject to the student has scored 80% & above in X & XII Std. aggregate for UG programs.

(D) SCHOLARSHIP FOR WARDS OF FARMERS

25% of concession in Tuition fees is applicable for the ward of farmers (whose income is less than 5 Lakhs per annum) on submission of the farmer card authorized by the Government.

(E) SCHOLARSHIP FOR THE ORPHAN STUDENTS

100 % Tuition fees waiver is applicable for the Orphan students on submission of following documents/ condition: (i) Certificate from the Women Development & Child Welfare department confirming the orphan status. (ii) An affidavit by the applicant duly notarized given on stamp paper of Rs.10/- undertaking that the applicant is an orphan/destitute.

(F) SCHOLARSHIPS FOR THE MUSLIM STUDENTS

100 % Tuition fees waiver is applicable for the wards of Imam, 50 % Tuition fees waiver is applicable for the Muslim Girl Students and 10 % Tuition fees waiver is applicable for the general Muslim students.

(G) SCHOLARSHIP FOR THE STUDENTS SUPPORTED BY NGO'S

20 % Tuition fees waiver is applicable for the students supported by NGO's on the submission of authenticated letter from the concern NGO.

(H) SCHOLARSHIP FOR WARDS OF FRONTLINE WORKERS

20 % Tuition fees waiver is applicable for the wards of frontline workers on the submission of authenticated proof issued by the Tamil Nadu Government.

(I) SCHOLARSHIP FOR WARDS OF COVID VICTIMS

20 % Tuition fees waiver is applicable for the wards of COVID victims on the submission of authenticated proof issued by the Tamil Nadu Government.

CATEGORY 2: SCHOLARSHIPS IN HOSTELS

Free hostel facility for SC/ST students, Minority students, Girl students, wards of farmers, Orphans and Sports Quota

- Free boarding and Lodging for SC/ST students
- Food can be provided at the concession rate of Rs.1500/= per month for SC/ST students
- Food can be provided at the concession rate of Rs.2500/= per month for remaining category students.


We intend to pursue continuous improvement in our procedures, practices and review the policy on a regular basis to evaluate continued relevance and to monitor compliance.
